PGET-2022 - ADMISSION TO POST GRADUATE MEDICAL AND DENTAL COURSES FOR THE YEAR 2022-23 IN THE STATE OF KARNATAKA AND

ADMISSION TO IN-SERVICE SEATS OF DNB (PRIMARY AND SECONDARY) AND DIPLOMA (NBEMS)

- 1) With reference to DME letter No. DME/PGS/10/2022-23 dated 07-09-2022, KEA is inviting applications online for admissions to PG Medical and Dental courses from the eligible candidates who have qualified in NEET-PG-2022 / NEET MDS 2022 for the year 2022-23 for the available PG Medical and Dental Degree / Diploma courses in Government Medical / Dental colleges, Government Quota seats in Private and Minority Medical and Dental Colleges and Private seats in Private Medical and Dental colleges (KPCF, KRLMPCA, AMPCK and Private Universities) located in the State of Karnataka for the academic year 2022-23.
- 2) As per Government order No. HFW 882 HSH 2021 Bangalore Dated 10-01-2022, KEA is also inviting application online from the eligible Karnataka in-service candidates who have qualified in NEET-PG-2022 and desirous of applying DNB / Diploma Courses in the State of Karnataka for the academic year 2022-23.
- 3) The candidates who have scored more than or equal to the prescribed minimum score in NEET PG 2022 / NEET MDS-2022 only are eligible to register and apply online for PG Medical and Dental courses for the year 2022-23.
- 4) Non-Karnataka candidates will not be eligible for reservation. Hence, in the NEET-PG 2022 / NEET MDS 2022 examination, if they have scored the required minimum 50th percentile or above, fixed for 'GENERAL (UR)' category as per the qualifying criteria, then only they are eligible to register for admissions through KEA or for any other seats in the State of Karnataka. Please note that SC / ST / OBC eligibility criteria are applicable to Karnataka SC / ST / OBC candidates only.
- 5) Portal is enabled to register and apply online for PGET-2022 from 19-09-2022; interested candidates have to register & pay the fees through online before 4.00 PM on 23-09-2022 and application can be submitted online upto 23-09-2022 11.59 PM.
- 6) Registration fee, schedule for verification of documents, original documents to be produced for verification and other details will be hosted on the KEA Website. Interested eligible candidates can register and apply online and appear for document verification as per the schedule.
- 7) Information Bulletin-2022 detailing admission eligibility criteria and other details are hosted on the KEA Website: http://kea.kar.nic.in for the information of the candidates.
- 8) Mere qualifying in NEET-PG 2022 / NEET MDS-2022 does not confer any right on the candidate for admission unless the candidate fulfils eligibility conditions / submits the documents / certificates. Further, only the candidates who complete the registration process including document verification are eligible for PG Medical / Dental seats in Government / Private Colleges in Karnataka.
- 9) Registered but not verified / Unregistered candidates will not be allowed for any admission either through KEA or by the College, as after the mop-up round, the list of registered and verified (holding verification slip) but un-allotted candidates will be sent by KEA to colleges to fill-up vacant seats, if any. (As per GOI instructions)

NOTE: All the candidates who have qualified in NEET-PG 2022 / NEET MDS-2022 are hereby advised to register online and complete the document verification process to become eligible for admission to PG Medical / Dental (Degree / Diploma) Courses in the State of Karnataka.
