The pay scale is in the grade of ₹ 60,000-1, 80,000/- with an increment of 3% per year. Besides Basic Pay, the employee is entitled to allowance @ 35% of Basic Pay under Cafeteria Approach, Dearness Allowance, HRA/Company Accommodation, Contributory Provident Fund, Conveyance Maintenance, Substantial Performance Related Pay (PRP), Medical Facility for self and dependents, Gratuity, Post Retirement Benefit Scheme and Composite Social Security Scheme as

- The courses offered by Institutes / Universities through the regular mode should be approved / recognized by the relevant statutory bodies for employment to posts and services under the central Government like Association of Indian Universities (AIU)/ UGC/AICTE etc. Candidates who have obtained their qualification through Distance Learning / part time mode are also eligible to apply provided their qualification is recognized by the relevant statutory bodies for employment to posts and services of the central government.
- Calculation of percentage of marks in the qualifying degree is as per University / Institution rules.
- Wherever CGPA/ OGPA/ CPI/ DGPA or letter grade in degree is awarded, equivalent % of marks should be indicated in the online application as per norms adopted by concerned University/ Institute. Please also obtain a certificate to this effect from the University/ Institute, which shall be required to be submitted at the time of interview. If university/Institute does not have the provision for conversion CGPA/ OGPA/ CPI/ DGPA or letter grade into percentage than the equivalence will be established by dividing the candidate's relative grade with maximum possible corresponding scale and multiplying the result with 100.
- Candidates must be able to produce mark sheet and course completion certificate with minimum 60% of marks in the essential qualification issued on or before 31/07/2022 failing which their candidature will be treated as cancelled.
- Where the posts specified in this advertisement are not reserved for a category (ies), a reserved category candidate can also apply provided she/ he fulfill the criteria specified for Unreserved Category. She/ Heshall be treated at par with unreserved category candidates in selection process.
- Candidates seeking reservation under EWS will have to submit at the time of document verification before interview, an Income and Asset Certificate issued by a competent authority. The prescribed format and the competent authority have been mentioned in DOPT Office Memorandum No. 36039/1/2019 – Estt (Res) dated 31/01/2019. A copy of the same can also be downloaded from the online application site
- Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and the vacancy will be filled by other than EWS candidates.

- Candidates seeking reservation as SC /OBC, will have to submit at the time of interview, caste certificate, only in the prescribed proforma meant for appointment to posts under the Government of India from the designated authority indicating clearly the candidate's caste, the Act/Order under which the caste is recognized as SC/OBC and the Village/Town the candidates is ordinarily resident of.
- Candidates seeking reservation as PWBD will have to submit at the time of document verification the benchmarked disability certificate only in the prescribed proforma as per Form V/VI/VII (Rule 18(1) of Rights of Persons with Disabilities Rules, 2017).
- iii. Prescribed format of the caste certificate for SC/OBC &disability certificate for PWBD for employment in government undertaking is down-loadable from the online application site.
- iv. OBC candidates must ensure that they possess the latest Non-Creamy layer certificate issued by Government of India authority from time to time. A certificate containing any variation in the caste name will not be accepted.
- No change in the category, already indicated by a candidate in his/her online application form for this exercise, will ordinarily be allowed.
- vi. As per the notification issued for CLAT Authorities for CLAT-2022, the eligibility criteria is different than that of ONGC but for recruitment for Assistant Legal Adviser in ONGC the minimum eligibility criteria would be as per Para 2 above.

3. SELECTION PROCESS: a. Eligible candidates meeting age and minimum eligibility criteria of ONGC as para 2 above and had appeared in Common Law Admission Test (CLAT)-

2022 for the purpose of admission in post graduate programme (LLM) in the National Law Universities will be considered. Candidates meeting the minimum eligibility criteria as per para 2 above will be shortlisted on the basis of CLAT-2022 Score for posts graduate courses (LLM).

- b. Score from CLAT-2022 examination ONLY is valid for this recruitment exercise under this advertisement. Scores from previous CLAT examinations are not valid.
- c. The candidates will be shortlisted in the ratio of five times of the vacancy for interview based on CLAT-2022 Score for LLM subject to have minimum 45% marks for Gen/OBC/EWS candidates and 40% marks for SC/PWBD candidates.
- d. The final selection of the candidate will be on the basis of following parameters - Educational Qualification; Performance in the CLAT 2022 for LLM Score and Performance in the Personal Interview. Following weightages shall be assigned to the parameters:

  - e. In order to be selected, candidates are required to be shortlisted based on marks obtained in CLAT-2022 exam for LLMand thereafter required to qualify again in the personal interview separately in addition to fulfilling qualification criteria.

### 4. Finalization of Merit List

- **a.** Candidates who qualify in the interview shall be empanelled in the Merit List.
- b. Offer of appointment shall be issued to the candidates based on their relative rank in the Merit List prepared on the weighted sum total of marks scored by the candidate in Qualification, CLAT-2022 for LLM Scoreand interview.
- c. In case of a tie in the total marks scored between two candidates, candidate who gets more marks in performance (Weightage of CLAT-2022 for LLM Score) is considered senior and if equal marks are scored in performance, then, the one older in age is considered senior for release of name.
- d. Departmental candidates shall be given first consideration in matters of selection, while other things such as qualification, eligibility and selection criteria etc. remain the same.
- e. Only CLAT-2022 for LLM Score is valid for the recruitment exercise in ONGC under this advertisement. Score from earlier or other CLATexamination is not valid.
- f. Appointment of selected candidates will be subject to their passing the company's Medical Examination as per standards laid down under ONGC Medical Examination of Employees Rules, 1996. Details of the rules are available on ONGC's Website at www.ongcindia.com.

### 5. How to Apply:

- a. Candidates who have appeared for CLAT-2022 examination for LLM may apply through Online Application with relevant link available at www.ongcindia.com after paying registration fee and entering the details such as CLAT-2022 registration number, roll no. etc.
- **b.** Registration Charges: The registration charges for different category of candidates is as under:

  - Registration fee is non-refundable.
  - Registration Fee has to be deposited online.
  - Departmental candidates from ONGC would also be required to deposit the applicable registration fee. However, the same would be reimbursable.
  - c. Candidates are advised to submit only one application. In case of multiple applications from a candidate the latest one shall be considered as final and older applications shall be rejected.
  - d. The candidates will be issued Call letter on their declaration in the online application. Mere issue of Call letter does not indicate that the eligibility of the candidate has been confirmed. The eligibility of the candidate is actually confirmed after document verification at the time of personal interview.
  - e. All correspondence with the registered candidates shall be done through their registered e-mail and mobile phone only. The candidates are required to keep the registered e-mail and mobile phone active at least for one year from the date of registration.
  - f. All information regarding candidates shortlisted for interviews etc. shall be available on the website of ONGC **www.ongcindia.com**. No separate Interview call letters shall be sent to the candidates by post.

- h. No changes shall be allowed once the candidate has submitted his/her online application.

All the candidates attending Personal Interview whose mailing address is out of the Interview city will be reimbursedsingle second class to & fro rail fare (inclusive of sleeper charges / reservation charges if paid) by shortest route or actual fare paid whichever is less. Based on the prevailing pandemic situation, the Interview may be conducted virtually. ### 7. General Instructions:

- **a.** All the candidates must fulfill the essential requirements of the post and other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying. No enquiry asking for advice as to eligibility will be entertained.
